



TERMS AND CONDITIONS FOR
'WIN AN AMZON ECHO'
PRIZE DRAW

1. The “Promoter” is The Royal London Mutual Insurance Society Limited, a company incorporated in England and Wales (company number 99064) and having its registered office at 55 Gracechurch Street, London, EC3V 0RL.
2. By entering this prize draw (the “**draw**”) entrants agree to be bound by these terms and conditions and any other requirement set out in the material relating to this promotion.
3. This draw is only open to registered independent financial advisers who are resident in the UK and over the age of 18. Only one entry shall be permitted per person. Multiple entries will be discounted. Automated entries, bulk entries or third party entries will be disqualified.
4. Entrants must not be an employee or contractor of the Promoter or any subsidiary of the Promoter or be in any other way connected with this draw (including relatives of any such person).
5. Entry to the draw is free and there is no requirement to purchase any products from the Promoter. Entries may be made by completing the online entry form which is available at this link: www.adviser.royallondon.com/conversation.
6. The draw shall open to new entries at 1pm on 5 February 2018 and shall close to new entries at 5pm on 19 February 2018.
7. Statistical data collected from the entries submitted may be used in subsequent marketing material by the Promoter but will only be used on an anonymous basis (for the avoidance of doubt individual entrants or their company name will not be named, subject to clauses 15 and 16).
8. There shall be ten winners and one prize of an Amazon Echo device per winner. The prizes will be subject to such terms and conditions as may be imposed by the ultimate issuer of the prizes. The Promoter shall not be responsible or liable for any costs beyond the initial purchase price of the prizes and the postal costs.
9. The draw will take place at 1pm on 20 February 2018.
10. The first ten names drawn at random from the entries received shall be the winners of the prizes. The draw will take place under the supervision of an independent observer. The full name of the independent person can be provided upon written request.
11. In the event of unforeseen circumstances making the administration of the competition impossible or impractical, the Promoter reserves the right to cancel the draw. In the event of such cancellation entrants shall be notified by email within 7 days of cancellation. The Promoter shall not be liable for any loss whatsoever as a result of cancellation of the draw.
12. The Promoter reserves the right to vary the prizes without prior notice to alternative prizes of equal or greater value. No cash alternative shall be available.
13. The Promoter reserves the right to refuse to award the prizes to anyone in breach of these terms and conditions.



- 14.** The winners will be notified no later than five days after the draw has taken place. The winners will be contacted by the Promoter by email and asked to provide an address for their prize to be sent to. If the winner does not reply to the Promoter's request for an address within 14 days, the winner will forfeit the prize and the Promoter is entitled to rerun the draw for the winner's prize in accordance with these terms and conditions. The supplier of the prizes will post the prizes within 21 days of the Promoter receiving notification of each winner's address. Prizes will only be sent to a valid UK address unless otherwise stated. All prizes will be sent by special delivery.
- 15.** By accepting the prizes, the winners will co-operate with any publicity activity associated with the prize draw, where reasonably requested by the Promoter, and agree that the Promoter may disclose the winners' names and counties of residence on the Promoter's website.
