Important change to your Royal London investment

What you need to know

Your pension is invested in the RLP BlackRock ACS Global Blend pension fund, which is made up of two underlying funds. We're writing to advise you that BlackRock are changing the benchmark for the underlying funds and will now move to track an Environmental, Social and Governance (ESG) screened index at the end of June 2021.

The change will address broad sustainability related factors and reduce risks related to a low carbon transition of the global economy.

The new indices will screen out certain stocks that do not meet specific ESG criteria such as controversial weapons, small arms and United Nations Global Compact violators as well as two fossil fuel screens related to thermal coal and oil sands.

How will this impact my investment?

We do not expect this change to have a material impact on the fund performance or impact the funds ability to perform in line with its new benchmark.


